



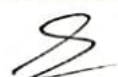

Counting of votes shall take place immediately after the polling hours under the supervision of Election Commission in the presence of Polling agents of the candidates, if any, at the polling site. The challenged votes shall be kept in separate sealed envelope duly signed and sealed by the Election Commission. Provisional results of election may be declared by the Election Commission.
